- 1. The Owner agrees to pay all horse sitting fees and other charges in advance of service provision in cash or by EFT.
- 2. It is the Owner's responsibility to insure the horses against all risks while under the supervision of the Horse Sitter. The Horse Sitter shall not be responsible for any disease, accident, illness or injury howsoever caused or arising to the horses whilst under her supervision.
- 3. The Owner agrees that in the event of injury or illness to their horse/s whilst under supervision by the Horse Sitter they give authority to same to call the emergency contact for advice, support and/or a decision to engage veterinary assistance.
- 4. In the event the emergency contact is unavailable, the Owner gives authority for the Horse Sitter to engage veterinary assistance if required, the costs of which will be the responsibility of the Owner.
- 5. The Horse Sitter will make all reasonable attempts to discuss the health and well being of the horse with the Owner or nominated alternate contact prior to engaging veterinary assistance.
- 6. Only on-site veterinary assistance will be offered unless otherwise requested by the Owner and arranged by the alternative contact. The Horse Sitter will not be responsible for transporting the horse off the property for medical treatment.
- 7. The Owner agrees to provide an alternative contact to call in the event additional assistance is required. For example in the event of a pending bushfire it is the Owner's responsibility to determine a course of action with respect to the safety of their horse and in the event they

#### Horse Sitting Agreement

Horse Sitting rate is 25.00 per day (up to 2 horses) 10.00 per day each additional horse. . Service includes:

- Visit twice daily.
- Rugs /fly veils on and off as deemed appropriate by the Owner.
- Preparation and distribution of hard feed and hay as required by the Owner.
- Check water, horse fences and make general observations of the property if required.
- Regular digital updates and photos (Facebook, texting) provided to owner.

Poo pickup can be negotiated.

Travel is extra and charged at the rate of 0.70c per km.

NOTES:

• This service applies to horses only. No other animals will be supervised.
