Short- Term Horse Agistment Agreement

This Agreement is made the _____ day of _____, 202__ between the Agistor/landholder, Helen Ward, Rosewood Park, 8 McIntyre Road, Yarragon'South, ph 0438 594285 and _____ the (Owner/s), phone _____, address _____

whereby the Agistor agrees to agist the Owner's horses identified on page 3 (the Horse/s) at the Agistment property at address 8 McIntyre Road, Yarragon South, 3823 on the conditions set out below.

1. The Owner agrees to pay all the agistment and other charges in advance of service provision in cash or by EFT.
2. It is the Owner's responsibility to insure the horses against all risks while they are at the agistment property or being transported to and from the property. The Agistor shall not be responsible for any disease, accident, illness or injury howsoever caused or arising to the horses whilst transporting to or from the Agistment property or at the property.
3. The Owner must notify the Agistor immediately the Owner becomes aware that the horses have been in contact with any significant or notifiable sickness, disease or injury.
4. The Owner agrees that in the event of injury or illness to their horse whilst at the Agistor's property they give authority to the Agistor to engage veterinary assistance if required, the costs of which will be the responsibility of the Owner.
5. The Agistor will make all reasonable attempts to discuss the health and well being of the horse with the Owner or nominated alternate contact prior to engaging veterinary assistance.
6. Only on-site (at Agistor's property) veterinary assistance will be available unless otherwise requested by the Owner and arranged by the alternative contact. The Agistor will not be responsible for transporting the horse off the property for medical treatment.
7. The Owner will ensure drenching and vaccinations (strangles and tetanus) are up-to-date prior to arriving at the Agistor's property.
8. The Owner agrees to provide an alternative contact to call in the event additional assistance is required.
8. The Owners to confirm the horses on agistment are not windsuckers or post chewers.

Short-Term Holiday Horse Agistment rate is \$90.00 per week .

Service includes:

- ◆ Private paddock.
- ◆ Quality grass hay fed daily.
- ◆ Rugs /fly veils on and off as deemed appropriate by the Agistor or by instruction from the Owner.
- ◆ 24/7 supervision by a reliable, experienced horse owner.
- ◆ Regular digital updates and photos (Facebook, texting) provided to owner.

Hard feeding can be arranged and will incur an extra fee of \$4.00 per feed per horse.

Attendance at farrier, vet or other appointments in lieu of Owner can be arranged for a small fee.
